Islam, The Great Delusion

Segment One

I want to start out by wishing everyone a merry Christmas. Let me encourage you to remember the real reason for this holiday. We celebrated the birth of our Saviour who came do die on the cross to pay our sin debt.

In these last days we need to be awake because there are those who will try to deceive us. It is a characteristic of the last days.

And for this cause God shall send them strong delusion, that they should believe a lie: (2 Thessalonians 2:11)

I know I am taking this verse a little out of context, but why is it that our nation is believing a lie? Why are we becoming weaker and weaker in dealing with an enemy? I believe the delusion concerning our enemy, Islam, will be the undoing of America.

We have said many times that we believe that America is under the judgment of God for her sin. We also believe that we are dealing with the circumstances of the last days. We know that in the last days there will be great deception. The verse above is dealing with the revelation of the son of Perdition, the Antichrist. The context talks about the love of many growing cold and tells us that people will no longer be lovers of the truth. They will be turned over to a deluding spirit. This verse is telling us that God allows this by removing His hand.

We believe that Islam is the deluding spirit. This can be seen by how it is deluding people around the world. Islam is an anti-Christ spirit in that it denies the Lord Jesus Christ. The end-time prophecy of Islam indicates that it could be the anti-Christ spirit of the end times.

The Bible warns us about these last days. This is the only explanation for what is happening in our government and in our schools. It is the only explanation of why the investigations in Homeland Security and the FBI are being tampered with and shut down.

We will be talking about the Muslim Student Association (MSA) promoting the wearing of the Hijab and a professor in a Christian college promoting the Hijab also. We will be looking at a school in Virginia practicing calligraphy by actually writing out the Shahada, which is the prayer to become a Muslim.

This is insanity, and I believe the only explanation is spiritual deception. This is why we must be grounded in truth. We must come to the corner of Truth and Courage. We must stand for what is right and speak out. We must be outraged, not in the sense of hollering and shouting, but to the point of action in the face of evil.

We believe there is conspiracy at the highest levels of government. One example of this is seen in what Customs and Border Patrol analyst Phil Haney said. He tracked members of the Islamist Deobandi movement. Sayed Farook and his wife, Tashfeen Malik, were affiliated with this group. According to Haney, when the Department of Homeland Security shut down his investigation they deleted the records. When he blew the whistle he was disciplined.

Haney said he worked in Passenger Analysis Units at the Department of Homeland Security in Atlanta and at the U.S. Customs and Border Protection's National Targeting Center, where he performed research into people and groups that might be linked to terrorism. He identified members of [al-Huda](#) and [Tablighi Jamaat](#), subgroups of the Deobandi Movement, a century-old fundamentalist Islamic group originating in Pakistan, as they traveled into and out of the United States. An association with Tablighi Jamaat has been documented by the French in an estimated 80% of terrorism cases. Dar Al Uloom Mosque, frequented by Sayed Farook, is linked with the Deobandi Movement. Tashfeen Malik studied with Al-Huda in Pakistan. ([The Federalist, 12/10/2015](#))

Haney was one of those who helped found Homeland Security. He has tracked down over 300 terrorists, and is a hero in my book. The Obama administration is trying to discredit him because he has exposed what is going on in Homeland Security.

If Haney's investigation had continued it is probable that Syed Farook would have been on the no fly list. He would not have been able to have gone over and brought Tashfeen Malik back into the country.

The Civil Rights Division of Homeland Security stopped the investigation, saying he was violating their civil rights because they were Muslims. His superiors deleted files from his investigation because they were following an Islamic thread. People go to jail for tampering with evidence.

If Haney's investigation had continued it would have pointed to the mosque where Sayed Farook worshiped and it could have prevented the San Bernardino attack. We believe that the order to destroy the files came from the White House. This is criminal conspiracy, criminal interference, and obstruction of justice. All of these charges can be put on those who ordered him to destroy evidence, ordered him to stop an investigation, and prevented him from doing his job.

This action cost lives. We are talking about 14 people being killed. This could have been prevented. This blood is on their hands. They are criminally responsible. This is part of the reason we believe, as we said last week, that there is [treason in the White House](#).

There was the threat of a terrorist attack in Los Angeles this past week that resulted in 900 schools being shut down and 650,000 kids told not to come to school. The reason the threat was taken seriously was because of the San Bernardino attack.

Haney is not the only anti-terrorist official that has been pushed out. John Guandolo, the man who put together the first terrorist training materials for the FBI, was also pushed out. All mention of Islam has been expunged from the training materials. This is a pattern we see that ties the hands of our security investigators.

The last attack was in San Bernardino. The next one could be in your community. It could be your children's school that is shut down. How many Americans have to die before Christian patriots get outraged enough to stand up and demand a change? We may not be able to have the President removed, but we can demand changes in the policies.

James Comey, the Director of the FBI, is under tremendous pressure. His job is to defend America from these kinds of attacks. He is to keep politics out of his agency. The White House keeps sticking its nose into the business of the FBI. I am thankful that he has the courage to push back and call the San Bernardino attack what it was, a terrorist attack.

We need to support people like James Comey. We need to support our law enforcement officials and pray that they won't bend to someone I believe is aiding and abetting the enemy.

Policy Exposed

What I want to talk about next is a policy that, although it is not new, it was just exposed. This policy made it difficult to properly vet Tashfeen Malik and could have prevented the San Bernardino attack. There were things in her social media account that could have warned us of what was to come. She posted things about ISIS and her loyalty to the caliphate set up by this group.

The Islamic world, especially the youth, is enamored with this new caliphate. The goal of Islam is to establish a world-wide caliphate which brings the whole world under Shariah law and in submission to Allah. The last caliphate ended after WWI and Islam has been without a caliphate for many years.

Tashfeen Malik was praising the caliphate and the work of ISIS on her social media account before she applied for a visa. Why didn't they check out her social media account? It would have shown where her allegiances were.

We are obligated to ask why this was not done. It has been revealed by John Cohen, the Under Secretary for Intelligence and analysis, that this administration prohibits the checking of social media accounts for foreigners applying for visas.

It has been reported by [The Daily Caller](#) that the government monitors American social media accounts, but not the accounts of visa applicants. They are giving foreigners more privacy rights than American citizens.

John Cohen said:

“There were concerns from a privacy and civil liberties perspective that while this was not illegal, that it would be viewed negatively if it was disclosed publicly.”

He was afraid that they might think he was discriminating concerning the applicants. Wait a minute, Don't we want them to discriminate when screening people for visas?

They are monitoring Americans and won't monitor those trying to come into our country. I wouldn't be surprised if there are government officials monitoring this ministry.

The fear of trampling Tashfeen Malik's civil liberties cost the lives of 14 American citizens. My question is, what civil liberties did she have? She is not a citizen, nor is she a resident of the United States. Our Constitution did not apply to her. We also know that she lied in at least 3 places on her application. There are many reasons why her visa should have been denied.

Let me say what they really mean. They don't want to offend Muslims. This is the bottom line. This is what Obama is saying, what Loretta Lynch is saying, what Jon Johnson is saying. They are doing everything in their power not to offend Muslims no matter how many American lives it costs.

This has become more than political correctness. It has become criminal conspiracy, obstruction, and so forth. They should be going to jail because it is costing lives. Blood has been spilled on American soil because of these treasonous government officials.

Some say we should not call them anti-American. It is not anti-America, it is anti-Constitution. It is against our laws, against Christianity, and against the founding principles of this nation.

This administration is doing everything it can to tie the hands of law enforcement and keep them from investigating those things that could lead to exposing Islamic terrorists. It is all because Obama said he was going to transform America, and he is transforming it into an Islamic country.

The pace that things are moving is startling. It is like we are repeating the events leading up to WWII. I have talked to people who lived through those times. They saw the rise of Hitler. Muslim Judge Sworn In On The Qur'an

In New York they have just [sworn a woman judge in using the Qur'an](#). Carolyn Walker-Diallo was sworn in as a civil judge for the 7th Municipal District at the Brooklyn Borough Hall, New York, using the Qur'an, rather than the Bible. Her community elected her.

Why does a community elect a Muslim to be their judge? The reason is that the community has become Islamic. Muslims now outnumber non-Muslims. We have been warning you what would happen when they outnumber us. This is a pattern we have seen in Europe. They are trying to outnumber us so they can beat us in the ballot box, or maybe on the battlefield.

New York has the highest population of Muslims in a single metro area. Dearborn, MI is the oldest Muslim community, but it is not the largest. Muslims are more established in Dearborn.

We know that people are blinded. They have listened to the lies and believed the deception and have become willingly ignorant.

This is not the first time we have seen someone sworn in on the Qur'an in America. Kieth Ellison, who is a sitting member in Congress, was sworn in on the Qur'an. We have warned people that Muslims can lie about their allegiance to our laws and our Constitution and secretly, in their hearts, have an allegiance to Shariah. We know that this is happening in the lower levels of government.

Using the Bible to swear people in to office is not just tradition, it is precedent. This is because our laws were founded upon the Ten Commandments and biblical precepts. When someone puts their hand on the Qur'an, they are saying their allegiance is to the Qur'an. They are saying that their allegiance is to Islamic law. If you follow Fortress of Faith you know that Islamic law cannot coexist with our Constitution and our laws. It does not allow for religious freedom, equal protection under the law, freedom of conscience, equality under the law for men and women, and so forth.

When this judge was sworn in, she was wearing a Hijab. She is not being secretive about where her allegiance lies. When she adjudicates, she doesn't even have to lie when she adjudicates according to Shariah.

Another problem with this is that New York has not protected itself from Shariah law coming into their courts. There are a few states that have passed laws along the lines of American laws for American courts that only allows the courts to accommodate foreign laws if the foreign laws do not violate constitutional rights of those being judged. This judge could accommodate Shariah law, and it is likely that she will because she was sworn in on the Qur'an.

The real danger here is that precedent is being set. This is the first time that I am aware of where a judge in America is sworn in on the Qur'an. We will see more of this happening as the Muslim population grows. They are being open about this because they are being given cover from the top of our government.

We have known for a number of years that the Muslim Student Association, a front group for the Muslim Brotherhood, has been given preferential treatment. In the state of Idaho, at Boise State University, the MSA was given the opportunity by the school to have an Islamic week. One of the days was "wearing a Hijab day."

The Hijab is the headscarf worn by Muslim women. It is required in Islamic law, it is part of the Shariah, and when you see it, it means that someone is submitted to Islam and to the law of Islam. Muslim women can show their face, but not their hair. Supposedly Muslim men can't control themselves and when they see a woman's hair they go into a sexual frenzy.

Schools Encouraging The Hijab

A number of Schools are encouraging girls wearing the Hijab to see what Muslim girls feel. Chicago's Vernon Hills High School had a "[walk a mile in a Hijab](#)" day. This was put on by the MSA. This organization was originally on college campuses, but they now have branches in some of our high schools.

They had non-Muslim girls encouraged, not forced, to wear a [Hijab to school](#) so they could walk a mile in a Hijab and feel what Muslim girls feel. Of course they claim that this is not promoting Islam. Did they have an event the next day called "wear a cross day" so Muslim girls could feel what Christian girls feel? Or maybe they could have had a "wear a star of David" day so we can help people understand what it is like to be a Jew in today's environment. There is a major rise of antisemitism on college campuses in America.

I call this the cultural jihad. It is the inch by inch, step by step, wearing down of our society and our culture. They are waring against our culture by bringing their dress and their customs based upon their faith, their religion.

This is not a cultural teaching event, it is a religious teaching event. As the Muslim girls put the Hijab on 17 non-Muslim girls, which symbolizes being submitted to Allah, they spoke to them about the religion of Islam. Muslim means the submitted one. Not only did students participate, teachers also participated.

This was not an after school event. Schools may have Christian student associations that meet outside of school hours on school property, but not with the school's participation. This happened during school hours.

Another story along the same lines comes from [Wheaton College](#). This is an evangelical Christian college. A professor named Larycia Hawkins announced on December 11th, on her Facebook page, That she would be wearing a Hijab during Advent to show “religious solidarity with Muslims... who are our brothers and sisters.” She further said:

"I stand in religious solidarity with Muslims because they, like me, a Christian, are people of the book. And as Pope Francis stated last week, we worship the same God,"

Wheaton College has come out with a statement that they do not support her in this, it is an independent decision by her. It is bad enough that she wants to show religious solidarity with Muslims, but she said that they worship the same God as Christians. Nothing could be farther from the truth. The God of Christianity and the god of Islam are in strong opposition one with the other.

Some will ask what is wrong with wearing the Hijab in trying to understand Muslims. If a woman visits and Islamic country like Iran, she must wear a headscarf or she can get in trouble. In any country that lives under Shariah law women must wear a head scarf as a sign of servitude and submission to Islam. How can a professor in a Christian college wear a Hijab in solidarity with Muslims? The only thing I can say is that this is delusional.
